# Plainview Public Schools Board of Education Meeting Monday, December 12, 2022

The regular monthly meeting of the Board of Education of District 5 of Plainview, NE, was called to order at 7:00 p.m. by Mike Sauser, President, on Monday, December 12, 2022. Frahm moved, Rasmussen seconded to declare an open meeting. Upon roll call vote, the ayes were unanimous. Motion carried. The rules for open meetings were posted at the back of the room. Roll call was answered by Sauser, Tim Rasmussen, Deb Jensen, Wyatt Frahm, and Chance Anderson. Jim Thor was absent and excused.

Rasmussen moved, Anderson seconded to approve the agenda. Upon roll call vote, the ayes were unanimous. Motion carried.

# **CONSENT ITEMS**

Consent items included the minutes of the November 14, 2022 regular meeting, the financial reports, and the December claims. The financial report (with last month's figures in parentheses) showed a balance of \$17,586.57 (\$474,691.72) in the General Fund. CDs total \$1,000,000.00 (1,000,000.00), Special Building Fund \$184,177.56 (\$181,976.32), Petty Cash \$524.01 (\$2,240.22), Activity Account \$111,174.42 (\$71,832.25), Lunch Account \$58,383.52 (\$66,015.00), Employee Benefit Fund \$52,484.51 (\$52,448.87), Depreciation Fund \$56,258.92 (\$56,220.72), Payroll Account \$3,997.76 (\$3,505.97), Custodial/Section 125 Account \$21,122.42 (\$19,139.64). Total assets were \$1,394,224.93 compared to \$1,778,001.52 a month ago, and \$1,445,462.49 a year ago. November receipts totaled \$70,119.04 compared to \$291,776.06 in October. Disbursements totaled \$527,544.42 including \$150,069.19 for claims, \$377,475.23 for payroll. Building Fund receipts totaled \$2,201.24. There were no Building Fund expenditures. Claims to the General Fund totaled \$111,484.76. Frahm moved, Jensen seconded, to approve the consent items. Upon roll call vote, the ayes were unanimous. Motion carried.
