Plainview Public Schools Board of Education Meeting Monday, July 8, 2024

The regular monthly meeting of the Board of Education of District 5 of Plainview, NE, was called to order at 7:00 p.m. by Tim Rasmussen, President, on Monday, July 8, 2024. Frahm moved, Anderson seconded to declare an open meeting. Upon roll call vote, the ayes were unanimous. Motion carried. The rules for open meetings were posted at the back of the room. Roll call was answered by Rasmussen, Wyatt Frahm, Melissa Doerr, Mike Sauser and Chance Anderson. Deb Jensen was absent and excused.

Anderson moved, Sauser seconded to approve the agenda. Upon roll call vote, the ayes were unanimous. Motion carried.

CONSENT ITEMS

Consent items included the minutes of the June 10, 2024 regular meeting, the financial reports, and the July claims. The financial report (with last month's figures in parentheses) showed a balance of \$1,765,940.95 (\$1,744,678.63) in the General Fund. CDs total \$600,000.00 (600,000.00), Special Building Fund \$109,959,77 (\$365,434.94), Petty Cash \$2,500.90 (\$2,325.66), Activity Account \$14,830.83 (\$17,877.21), Nutrition Account \$48,632.22 (\$49,517.14), Employee Benefit Fund \$53,824.30 (\$53,752.55), Depreciation Fund \$73,550.82 (\$73,452.78), Payroll Account \$13,517.75 (\$14,427.88), Custodial/Section 125 Account \$20,147.16 (\$18,335.12). Total assets were \$2,492,152.53 compared to \$2,795,486.62 a month ago, and \$2,324,440.44 a year ago. June receipts totaled \$508,129.05 compared to \$1,695.297.07 in May. Disbursements totaled \$486.866.73 including \$144,315.29 for claims, \$7,642.47 for Navigator invoice and \$334,908.97 for payroll. Building Fund receipts totaled \$23,058.36. Building fund expenditures were \$278,533.53. Claims to the General Fund totaled \$210,752.17. Sauser moved, Anderson seconded, to approve the consent items. Upon roll call vote, the ayes were unanimous. Motion carried.
